

**RULES & REGULATIONS**  
**FIVE YEAR DUAL DEGREE PROGRAM B. TECH – M. TECH (CSE AND ECE)**

**Preamble**

1. The Dual Degree Program B.Tech-M.Tech in the Departments of CSE/IT and ECE shall entitle the students for the Dual Degrees as follows:
  - (i) B. Tech
  - (ii) M. Tech
2. The students joining the Program cease the right to exit the Program at the end of four years or completion of B. Tech Programs requirements. He/she shall be awarded the degrees of B. Tech and M. Tech together, only after fulfillment of requirements laid down in succeeding paragraphs and not earlier than five year period, as prescribed for the Dual Degree Program.

**Admission Eligibility**

3. The students shall be admitted directly into the Program, as per admission policy laid down from time to time by the Management. The procedure of admission shall generally remain the same, as for regular B. Tech students i.e based on their all India Rank in Central Engineering Entrance Exam conducted by CBSE.

**Conduct of Program**

4. Rules Till completion of B Tech Degree requirements The students admitted to the Programs shall be governed by the Rules & Regulations, laid down in the Academic system for B. Tech Program already existing or as modified from time to time except as laid down on succeeding paragraphs.
5. Rules for the M Tech Degree requirements The students having done the B Tech requirements shall thereafter be Governed by the requirements of M Tech program i.e during additional summer semester and last (9<sup>th</sup> and 10<sup>th</sup>) two semesters dealing specifically with M Tech courses
7. **Course Structure**  
The curricula of the B. Tech Program may be modified / integrated to meet the additional requirements of M. Tech Degree program.
8. **Evaluation and Grading System**  
The evaluation shall be carried out as per existing policy. The structure of grading of performance shall continue to be as per the Academic System governing the B. Tech program for the first four years and M.Tech program in the fifth year.
9. **Project / Thesis**  
The general instructions for submission and evaluation of Project work during B. Tech & M. Tech phase shall be same as per existing instructions and procedure laid down. Submission and evaluation of Thesis during M. Tech Program shall be governed by rules laid down in the M. Tech Ordinance of the JIIT.
10. **Conditions for Award of Degree** For a student to qualify for award of Dual Degrees of B. Tech & M. Tech following conditions are mandatory: -
  - (a) Obtaining a CGPA of 4.5 and above in the Program. The CGPA for both B Tech and M Tech shall be in continuation and calculated progressively.
  - (b) Earning a Minimum Credits as laid down in the program structure.
  - (c) All core courses must be cleared, as defined in the Dual Degree curricula both for B. Tech and M. Tech Programs.
  - (d) Completing the requirements of the Program in a maximum of seven years.

(e) Completion of requirement of Industrial Training as essential for B. Tech Program.

**11. Conditions for Progression and Termination of Registration** A student shall be de-registered if he / she fails to meet the following criteria for continuation of the Program: -

- (a) Fails to meet the requirements for progression as laid down in the Academic System for the respective phase's i.e. B Tech and M Tech.
- (b) The progress beyond six years shall be allowed only on approval of the Vice Chancellor.
- (c) No Degree shall be awarded in case a student fails to complete the requirements of the Dual Degree Program in maximum of seven years.

**13. Teaching Assistantship**

The Teaching Assistantship in the 5<sup>th</sup> Year shall be governed by the existing Rules for M. Tech students, subject to limitation on numbers selected for the award ,which shall be as decided by the management.
