ITEM 3: APPROVAL OF MINUTES OF THE LAST MEETING OF THE ACADEMIC COUNCIL AND REVIEW OF THE ACTION TAKEN REPORT

The Minutes of the last Academic Council Meeting held on Feb. 10, 2017, and the Action Taken Report were reviewed and approved.

ITEM 4: REPORT ON CURRENT PLACEMENT STATUS

Placement position for 2016-17 was noted. As a result of discussions, following points emerged:

- (a) Head Training & Placement and respective HOD will explore to find reasons for low participation of students in placement activities, for example, only 272 BTech students ECE students participated in placement out of a total of about 450 students.
- (b) It was brought out that some students after registering for a company do not turn up for the test/ interview. HOD's will try to find out possible reasons for the same.
- (c) In case of MBA, it was noted with concern that many high salary offering companies did not recruit a single student. JBS will make attempt to correct this situation.

ITEM 5: TO NOTE CHANGES IN 5TH, 6TH & 7TH SEMESTER B.TECH AND INTEGRATED M.TECH ECE CURRICULUM FOR BATCHES ADMITTED IN 2014 ONWARDS

Changes suggested in the Item were approved by the Council.

ITEM 6: TO CONSIDER INTRODUCTION OF A CEILING ON MAXIMUM MARKS TO BE AWARDED TO CANDIDATES APPEARING IN MAKEUP EXAMINATION

The proposal of a ceiling of 60% of maximum marks on marks obtained in 'Make-up' examination was approved by the Council. To be made applicable w.e.f. academic year 2017-18

ITEM 7: TO CONSIDER REVISION OF COURSE CODE SCHEME CURRENTLY IN FORCE

Proposed revised course coding scheme was approved by the Council. This will be effective from 2018 onwards and for revised MTech schemes.

ITEM 8: TO CONSIDER AND APPROVE EVALUATION SCHEME FOR SUMMER TRAINING OF B.TECH AND INTEGRATED M.TECH PROGRAMME STUDENTS AFTER 6TH SEMESTER
