ITEM-1: WELCOME AND OPENING REMARKS BY THE CHAIRMAN

The Vice Chancellor accorded a very warm welcome to all the members for having made it convenient to attend the meeting of the Board of Management. He profusely thanked the external members and special invitees for attending the meeting. The Vice Chancellor also thanked the outgoing members and welcomed the new members of BoM.

ITEM-2: LEAVE OF ABSENCE

ITEM-3: PRESENTATION BY THE VICE-CHANCELLOR ON THE PROGRESS OF THE INSTITUTE

The Vice Chancellor presented the progress of the Institute. The presentation is given as **Annexure – 1**. The summary of the discussion during the presentation is as given below:

(i) VC informed the members about the preparations for the NBA & NAAC accreditation due in the coming years.

- (ii) On the concern voiced by Prof. Agrawal regarding the University rankings by NIRF, VC informed that the inclusion of various Govt. Universities / Institutes over the years resulted in the change in rankings. However, the JIIT would endeavour to maintain and improve its NIRF rank.
- (iii) VC informed that three new M.Sc programmes and one new BBA programme have been started in the present academic year 2019-20.
- (iv) The concern was raised on the reduced admissions in M.Tech programs. Prof. Barua informed about the Govt. policy permitting students to pursue PhD after B.Tech without doing M.Tech. It was informed by the VC that there is a provision of pursuing PhD after B.Tech in JIIT also. Prof. Agrawal suggested flexibility in the Institute's procedure for admitting students to M.Tech.
- (v) On the query from Prof. Agrawal regarding the fellowship to PhD students, VC informed that the institute awards fellowship to all full time PhD scholars.
- (vi) It was suggested that the existing students be educated about the OBE process and also the new admitted students every year be made aware about the OBE system during the orientation program. The VC assured that this will be done.
- (vii) On the subject of IT infrastructure, Prof. Barua suggested to prepare a comparative chart of the IT Infrastructure as required by the UGC and AICTE and the availability in the Institute.
- (viii) Sh. Anand Bordia enquired about the method of quality comparison and the status of Indian Journals in comparison to the International Journals. It was informed that publications in Scopus and SCI / SCIE indexed journals are considered of quality and fall into International standards of publications.
- (ix) Prof. Agrawal enquired about the sponsorship for International Conference IC3 and suggested to explore the option of seeking sponsors for such a renowned conference. He also suggested to have decadal experience analysis and compilation of the most cited papers in all editions of IC3 conference. The VC informed that IC3 has h-index of around 15, which is considered a very good level for an International Conference.
- (x) It was suggested that the Institute may consider taking steps so that the students in the lower CTC of 3-5 Lacs could achieve a higher CTC during the placement drive.
- (xi) Prof. Alka Sharma informed the members about the activities under NSS. Sh. Bordia appreciated student participation in the Institute activities and said that such compassionate action assists in the mental growth of individuals. The VC stated that the millennial were more sensitive and compassionate in their outlook and activities towards social works and environment.

- (xii) It was suggested that the incentives given to the faculty members for finally awarded patents be mentioned on the JIIT website for wider dissemination.
- (xiii) On the subject of improving the quality of research, it was suggested that opportunities be explored for joint projects with the JIIT alumni who one working abroad in different research institutions / organizations.
- (xiv) Sh. Bordia & Sh. Alok Gaur while talking about publicity, advertising and perception, emphasized on the aspect of value creation of the JIIT brand.

ITEM-4: CONFIRMATION OF THE MINUTES OF THE LAST MEETING OF BOARD OF MANAGEMENT, HELD ON 30 MARCH 2019 AND ACTION TAKEN REPORT

The Board confirmed the minutes of the last meeting of the Board of Management and noted the Action Taken Report.

ITEM-5: BRIEF ON COMBINED UGC & AICTE EXPERT COMMITTEE VISIT TO JIIT NOIDA ON 20-22 MAY 2019

The combined UGC & AICTE Committee visited to review the functioning of JIIT and forwarded its suggestions and recommendations. The Vice Chancellor briefed the members about all suggestions and informed about the follow up actions being undertaken by the Institute for compliance of all suggestions.

UGC Expert Committee Recommendations:

"On the basis of the on-the-spot inspection of all the infrastructural facilities available in the institution, visit to all the departments, verification of all relevant documents and on the basis of the interaction with the stakeholders, the committee recommends that JIIT Noida may be allowed to continue as a Deemed to be University. However, the institution may be asked to comply with the suggestions made by this committee with in a stipulated period of time."

AICTE Expert Committee Recommendations:

"The committee visited all the departments, laboratories, libraries, central/ common facilities etc. of JIIT and interacted with all stakeholders. The committee is of the view that JIIT Noida is functioning well and has made significant progress as an institution in its capacity as a Deemed to be University for imparting technical and management education under the ambit of AICTE. The committee further recommends that the status of JIIT as Deemed to be University should be approved subject to the fulfilment of AICTE regulations and compliances to the suggestions made by this committee."
