Further, the meeting was also attended by Cmde. K.K. Rohatgi (Retd), VSM, Head T&P and Dean Students affairs and Sh. S.J.S. Soni, Chief Finance Officer, as special invitees.



WELCOME AND OPENING REMARKS BY THE CHAIRMAN **ITEM-1**:

The Vice Chancellor accorded a very warm welcome to all the members for having made it convenient to attend the meeting of the Board of Management. He profusely thanked the external members and special invitees and all members present for attending the meeting.

ITEM-2: LEAVE OF ABSENCE

The leave of absence was granted to the following members:

ITEM-3: PRESENTATION BY THE **VICE-CHANCELLOR** ON THE **PROGRESS OF THE INSTITUTE**

The Vice Chancellor made a detailed presentation to the members on progress of Institute since last meeting of the Board of Management, covering all important areas. Highlights of the presentation were as follows:

Infrastructure (i)

- (a) JIIT infrastructure in terms of value increased from Rs. 296 crores in 2014 to Rs. 330 crores in 2015.
 - Covered area in square meters increased from 148100 sq mtrs in (b) 2014 to 158079 sq mtrs in the current year due to newly added hostel.
 - (c) With the new laboratories coming up in ABB-I, the total number of laboratories will increase from 53 to 59 shortly.

- (d) Hostels seats have increased from 2634 to 2831 in the current year due to additional 197 seats now available in sector-128 campus. It was highlighted that JIIT is the only Institute in the NCR which offers so many hostel seats to its students.
- (ii) Developments since last Board of Management meeting were noted by the members, which included functionality of the new building to the tune of 80%, introduction of new academic programs, revision of UG

teaching scheme and new appointments at various levels.

(iii) It was expressed by the Hon'ble Founder Chancellor that now, with the basic infrastructure in place, JIIT should be seen as a University of '**par** excellence', and be known for its overall quality.

He also desired that the Convocation of the JIIT should now be held

every year.

- (iv) It was informed by the Vice Chancellor that there is increase in the number of books in the library.
- (v) The placement of eligible students in the last three year has shown significant improvement and in the year 2015 most of the students had multiple offers in their hands besides reasonable increase in their CTC with various companies.

M/s Amazon offered the highest salary of Rs. 18 lacs per annum.

The placements in case of MBA were reported satisfactory with as many as 57 companies visiting the campus for recruitment.

- (vi) It was informed by the Vice Chancellor that there is a significant improvement in the area of research and publications which include not only the Ph.D's awarded, but also the number of publications by JIIT faculty members and research students.
- (vii) It was also informed that in the last four years JIIT has funded research activities worth Rs.11.27 crores from its own resources.
- (viii) While concluding his presentation, the Vice Chancellor informed the Board regarding various academic strengths of JIIT like more than 50% faculty being Ph.D's, minimum qualification for faculty being Post Graduate for Engineering and Technology and Management and Ph.D for Sciences/ HSS. Large number of faculty members is from prestigious institutions like IITs NIT's & others. JIIT carries out periodic review of teaching schemes, focuses on increase in research based projects, encourages organization of international conferences on a regular basis and provides fellowship from its own resources to full time Ph.D. scholars.
