INSTRUCTIONS FOR THE SELECTED CANDIDATES

Congratulations on being selected to the Master of Business Administration (MBA) Program at Jaypee Business School (JBS), a Constituent of Jaypee Institute of Information Technology, Noida for the Batch 2017-2019. You are required to arrange for deposition of fee as per policy outlined and thereafter follow the schedules as given in succeeding paragraphs.

FEE DEPOSITION SCHEDULE:

- (a) The total Institutional fee for the 2-year MBA program for batch admitted in 2017 is Rs. 8 lacs i.e. Rs. 4 lacs per annum.
- (b) Further, the students are required to pay Rs. 15,000/- per year towards the cost of study material, books and also access right to Harvard Business School site, for case studies.
- (c) **Hostel Charges:** Rs. 1.10 lac per annum (Optional). Including boarding & laundry. The candidates shall initially be required to remit Rs. 30,000/- for blocking the hostel seat.
- (d) You are required to deposit **Rs. 50,000/-** (partial Institutional Fee) latest by **25-March-2017**. You may choose any one of the following option as per your convenience. Please send DD of Rs. 80,000/- (50,000 initial amount for institutional fee+30000 for hostel blocking) if desirous of taking hostel seat.
 - (i) Through Demand Draft in favor of **"Jaypee Business School"** payable at **'Noida/Delhi'**. OR
 - (ii) Through RTGS/NEFT as per the details:

Do not forget to mention your name and your father's name while transferring the fees and send the full details to Mr. Brijesh Biswas, Accounts at brijesh.biswas@jiit.ac.in with your Unique Reference Number (URN).
- (e) **The balance fee of Rs. 3.5 Lacs (Institutional Fee), Rs 15,000/- for study material and Rs. 80,000/- (balance hostel charges, if opted) for Academic Session 2017-18 shall be payable on the day of registration.**
- (f) If you do not register on the specified date i.e. **June 30, 2017** you will have no claim on the seat and Institute shall forfeit the same.

ACADEMIC SCHEDULE:

The regular classes for the new session shall commence on **July 3, 2017**. The Registration for the Academic Session 2017-18 will be done in person only on **June 30, 2017** at JBS, Noida. Late registration is not allowed. Failure to register shall lead to cancellation of your seat. You will be allotted an Enrollment No. after the Registration. The Enrollment No. is your personal identity and should be used for any reference with the Institute.

DOCUMENTATION:

You are required to produce the following documents (along with the balance fee) on the date of registration:

- (a) Original and one, self attested copy CAT/MAT/XAT/CMAT etc. score card as applicable.
- (b) Character and Migration/ Transfer Certificate in original from the Head of the Institute/University last attended.
- (c) Original and one, self attested copy of each of Marks Sheet and Certificate of High School (10th), intermediate (12th), Graduation or equivalent examination passes e.g. B.Tech./BBA/B.Com/BA etc.
- (d) Originals at (a) & (c) above shall be returned after verification.
- (e) Medical certificate of fitness from MBBS qualified doctor (on his/her letter head or letter head of the hospital) stating that you are free from any communicable disease. In case you are suffering from or ever suffered from diseases which need immediate medical attention like Congenial Heart disease, Rheumatic Septal Deficiency, Bronchial Asthma, Epileptic Fits, Diabetes Mellitus etc, the same must be mentioned in the medical certificate. No specific format is needed. Further, your medical history, if any, must be declared and informed to the medical officer of the Institute at the time of joining to enable quicker and suitable response in case of emergency.
- (f) Three copies of passport size colored photograph.
- (g) Notarized copies of Anti Ragging undertaking; one signed by the student and other signed by the parents. You may download the formats for same from website www.jiit.ac.in under Notice Board.
- (h) All JBS students shall be members of Jaypee Youth Club & required to pay a membership fee of **Rs. 700/-** yearly at the time of Registration.

Note:

- (i) Please ensure that you fulfill the eligibility criteria of admission i.e.
- 50% aggregate marks in graduation for those qualified/likely to be qualified by **July 31, 2017**.
 - No backlog course till pre-final year/semester at the time of registration.
 - The qualifying degree mark sheet to be submitted under all circumstances by **September 30, 2017**.
No extension for any reason like not being provided by University shall be accepted.
- (ii) In case you are not able to submit the academic documents listed above for the reasons beyond your control at the time of registration, you may be allowed to submit the same latest by **September 30, 2017** after giving an undertaking and on obtaining approval of the same from Director, JBS. In case you fail to submit the documents by **September 30, 2017**, the admission shall stand cancelled. Requests for extension of dates, for any reason whatsoever, shall not be allowed.

REFUND POLICY:

Please read the instructions, as below, very carefully on the Refund Policy. No representation shall be accepted, for ignorance or delay in request for withdrawal.

- (a) In compliance to Instructions of MHRD, the Institute shall refund the amounts deposited by the candidates who wish to withdraw before the date of registration (**i.e. June 30, 2017**), after deduction of Rs. 1000/- (Rupees one thousand only).
- (b) For those candidates who withdraw after Registration and before the last date of admission i.e. **July 31, 2017**, refunds shall be processed on monthly pro-rata basis, considering the academic year as ten months.
- (c) **No refund shall be admissible after the last date of admission i.e. July 31, 2017.**

GENERAL INSTRUCTIONS:

- (a) The medium of instructions and communication in the Institute is English.
- (b) Placement after education is a process dependent on knowledge acquired by students, his / her aptitude and attitude, besides the economic conditions prevailing around us.
