I. General

Unnat Bharat Shodh Foundation Scheme has been launched under the aegis of Jaypee Education System duly funded by the Jaypee Group of Companies with an initial corpus of rupees one crore.

II. Objectives

The objectives of the above scheme are to develop a synergy between institutions and industry. Its significant needs are:

- Need for Institutions having ready access to information on pressing industrial problems and on emerging concerns for improving productivity, quality and efficiency of existing products/technologies for enhancing global competitiveness.
- Need for industry to be fully aware of strengths of Institutions' faculty their areas of expertise and their problem solving experience and of the infrastructure facilities available in the Institution.
- Need for promoting research in new areas having potential for large-scale application on a long-term basis.

III. Functions

The Unnat Bharat Shodh Foundation, would invite Industry for giving donations and also encourage them to become active members in sponsoring activities of the Foundation and giving directions for undertaking investigations, as well as for research and technology development. The foundation would sponsor and fund promising research undertaken by the Institute faculty, bring student project successes to a product development stage, market faculty capability at the domestic and international levels, encourage peer interactions of faculty at national and international levels, and collaborate with other organizations/industry for undertaking products/system development for mutual benefit etc.

IV. Services Offered to Corporate Members

Industry academic interaction is considered an ideal that can become a potent instrument towards supporting industrial development. To strengthen the linkages between the Jaypee Institutes and Industry, the Foundation is offering a scheme of Corporate Membership. This membership is open to industries, associations, R&D organizations and financial institutions, which would like to support the concept of Institute-Industry Interaction and derive benefits resulting thereof.

Industry which become members of the Foundation on a permanent basis through one time donation or become annual members through an annual subscription would enjoy certain benefits and preferential treatment (to be specified) in all their interactions with the Institutions: sending employees for training, attending continuing education programs, getting problems solved through consultancy assignments, sponsoring long-term research, sponsoring field work or preparation of position papers on issues of industry's concern etc.

Specific benefits which can be derived by Corporate Members are:

- Review and update on ongoing R&D programs in the Institutes
- Access to consultancy services of the Institute
- Access to HRD and other programs of UBSF and the Institutes at concessional rates.

- Use of the Institute(s) Library and preferential access to specific laboratory facilities and workshops.
