The Academic Council meeting was Chaired by Prof SC Saxena, Pro-Chancellor.

ITEM 1: WELCOME AND OPENING REMARKS BY THE CHAIRMAN

The Pro-Chancellor welcomed all the members of the Academic Council and conveyed his gratitude to the external members for their presence in the Academic Council Meeting.

He informed members about the process to be followed for new admissions for the Academic Year 2021-22. The admissions cycles were divided into three phases for BTech and Integrated MTech programs i.e. Phase-1 commencing from 01 Sep 2021, Phase-2 from 08 Oct 2021 and Phase-3 from 15 Nov 2021.

He also stated that the students were being admitted under two modes i.e based on 10+2 marks and JEE (Mains) AIR 2021. Students have also been admitted under the NRI / NRI sponsored category. The Institute has offered admission to wards of Kashmiri migrants as per the MHRD (now MoE) letter. The lateral entry admissions in 2nd year BTech have been made this year and 72 students have been admitted. There is a steady increase in the BBA admissions every year. The process of admission is still continuing.

The end semester examinations for the current semester are being conducted in offline mode in the JIIT campus. The exam will be conducted in two rounds spread over 5-7 days in each round to ensure adherence of all COVID-19 mandate norms.

The Pro-Chancellor also informed about the Academic Calendar for the current Semester for all the phases.

He conveyed his appreciation to all the employees of JIIT for ensuring the smooth conduct of academic activities in online / offline / blended mode during the current semester starting from 31 Aug 2021.

The Pro-Chancellor conveyed his concern regarding the continued unsatisfactory admissions in the PG programs (MTech, MSc & MBA). He informed that a team has been constituted to analyse the situation and recommend the way ahead.

Prof. Brahmjeet Singh suggested that JIIT should consider interested candidates from the corporate sector for PhD

The Academic Council noted the Status of admissions till 06 December 2021.

The Academic Council noted the placement status of students graduating in 2021-22 for B.Tech, M.Tech, Integrated M.Tech and MBA programs along with the placement details for batches 2021-22, 2020-21 and 2019-20.

ITEM 8: REVISED POLICY FOR AWARD OF MEDAL OF MERIT TO THE MERITORIOUS STUDENTS:

The Academic Council noted and approved the revised policy (attached as Annexure-2).

ITEM 9: PROVISION OF COMPENSATORY TIME AND / OR SCRIBE AVAILABILITY DURING EXAMINATION FOR STUDENTS SUFFERING FROM BENCHMARK DISABILITIES:

The Pro-Chancellor informed the members that JIIT has been providing the necessary assistance in consonance with the UGC letter F. No. 6-2/2013 (SCT) dated 14 Jan, 2019 (attached as Annexure-3):

- (a) A student with disability is provided extra/ compensatory time and/ or scribe/ reader/ lab assistant in the written examinations on his/ her request.
- (b) The compensatory time in the written examinations may be minimum one third of the duration of the written examination.

The academic council noted the provision and approved the same.

ITEM 10: SUPERANNUATING FACULTY AS GUIDE FOR PHD SCHOLARS:

The Pro-Chancellor informed the council members that as per the UGC norms and academic system of PhD program of the JIIT, only full time regular teacher can be appointed as a PhD supervisor.

The following proposal for a superannuating faculty guiding a PhD student at the time of superannuation was approved by the Academic Council:

- (a) If a superannuating faculty member is the sole Supervisor or Supervisor 1 or 2, then in place of the superannuating faculty member, a new Supervisor will be appointed as per the UGC norms on the recommendation of HoD and Dean-A&R and approval of the Vice Chancellor, for further guidance of the Ph.D. Scholar. However, if the superannuating faculty member is permitted to continue in JIIT after superannuation in the same capacity then, he/she may be considered to continue as Supervisor-2 till he/she remains in the service of JIIT or the Ph.D is submitted, whichever is earlier.
- (b) No new Ph.D. student to be enrolled under a faculty member for guidance whose superannuation is due within a period of next 3 years.
