V.Sc. and B. Pharma with at least 50% marks (45% for SC/ST) or equivalent grade point on a 10-point scale in the aggregate. *Provisional Admission: Students who are in the final year are eligible to apply for admission. The admission is subject to successful completion of graduate University/Institute will admit students under DBT support through centralized selection process only i.e. GAT-B National Level entrance exam conducted by DBT programme & meeting the minimum eligibility criteria

SELECTION PROCESS:-

Candidates desirous of seeking admission to the M. Tech. Biotechnology program under this scheme will be admitted based on the rank obtained in GAT-B (Graduate Aptitude Test Biotechnology) 2025 conducted by Regional Centre for Biotechnology on behalf of Department of Biotechnology, Government of India.

CONFIRMATION OF SEAT TO THE PROGRAM:-

Upon declaration of results, selected candidates have to deposit the Tuition Fee well within the allowable time as per Admission schedule. In case candidate fails to deposit the fee well within the time, claim for admission will stand cancelled and seat to the program will be offered to the next candidate in order of merit.
